- All participants must be currently in grades 8th –12th and of the appropriate age, and MUST provide proof of school attendance.** This proof may be one of the following: report card, class schedule, school ID card, or similar document.
 - Each participant will receive a photo ID card and these ID cards will be kept at the YMCA by the Teen Center staff. **No admittance will be allowed until Teen Center staff members validate identity by checking the ID cards on file at the Rauch desk.** Every participant must sign in at the Rauch desk.
 - Teen Center hours of operation are 8pm – 10pm.**
 - There are two 45 minute swim periods from 8:15pm – 9pm and 9:15pm – 10pm.
 - The Strength Training Center (STC) is open from 8pm – 10pm
 - The HEC is open from 8pm – 9:55pm.
- Participants must be prepared to exit all YMCA facilities (and be picked up) by 10pm. SUFFOLK COUNTY POLICE WILL BE NOTIFIED OF ANY CHILD NOT PICKED UP OR REMAINING ON THE PREMISES AFTER 10:30pm.**
- Proper attire is required in all areas.** Bathing suits must be worn in the pool (no cutoffs, jeans, or T-shirts). Sneakers and proper workout attire must be worn in the STC. Teen Center staff can prohibit participants from using the pool or STC if they deem their clothing unsuitable for that activity.
 - The pool will be open for two 45 minute swim periods:** 8:15 – 9pm and 9:15 – 10pm. Each swim time will be capped at 40 swimmers. Teens will be required to sign up for a swim time when checking in. The first swim slot will be filled on a first come first serve basis. Swimmers who did not swim in the first swim slot will be given priority for the second swim slot. If spots still remain, then those remaining spots will be filled first come first serve.
 - Abuse or misuse of equipment** in the STC or breaking the rules in either the pool or STC **will not be tolerated.** Teen Center staff has the right to remove you from the premises if these rules are broken and possible suspension from Teen Center may occur.
 - The Huntington YMCA is not responsible for lost belongings.** Locks for the lockers are highly recommended. Teen Center staff will hold your belongings for the first week only if you did not bring a lock. Please leave valuables at home.
 - All participants must behave in a **respectful manner** to fellow teens and staff, and **respect** YMCA property. Any participants, who are found to be disrespectful will receive a phone call home, will be asked to be picked up, and Teen Center suspension may occur. Offensive language and horseplay/inappropriate behavior or physical contact will not be permitted at Teen Center.
 - Participants **cannot hang out on the grounds in non-program areas. Loitering** in these areas **will not be tolerated.** Any teens not participating in the included activities will be asked to leave.
 - On occasions, **PG13+ movies** may be shown during Teen Center. By signing this contract, you are giving your child (the above named person) permission to watch these movies.
 - Weapons** of any kind, **illegal drugs, cigarettes and alcohol are not permitted** on the YMCA campus. **This rule is strictly enforced.** Participants, who appear to be under the influence of any of the above, will not be admitted and will be asked to leave the YMCA campus. **Anyone caught breaking these rules will have their Teen Center privileges suspended.** The YMCA is a smoke-free campus.
 - Parents/guardians are responsible for **prompt pick-up at 10pm.** The Huntington YMCA is **not responsible** for participants who leave the YMCA campus during Teen Center hours or who choose to walk home. If a teen is walking home, please alert a staff member.
 - The Teen Center Director will have the final say on all rules and regulations set out in this document and those who do not abide by the above ground rules are subject to suspension from the program at the discretion of the Teen Center Director.
 - A parent or guardian signature is required along with all pertinent information to register and use the facility for Teen Center. You will not be able to enter without it and there will be no exceptions to this rule.**
 - All participants and parents/guardians must read and sign this contract. Once they do, they agree to abide by all rules and regulations outlined in this document.
