Congratulations on starting your senior year of high school! I hope you had an enjoyable summer.

Many of you have or will be getting your senior driver's license. If you will be driving to school daily or even just occasionally, your car must be registered with us so you can park on school grounds.

If you are going to drive to school you will need to get a parking permit. Please bring **A COPY OF THE FOLLOWING DOCUMENTS FOR US TO KEEP IN OUR OFFICE. WE WILL NOT MAKE COPIES OF THESE ITEMS HERE AT SCHOOL AND NO PARKING PERMITS WILL BE ISSUED WITHOUT THE RECEIPT OF ALL OF THE BELOW DOCUMENTS:**

Senior Driver's License (Class D)
Registration Card (for each car you will be driving to school)
Insurance Card (for each car you will be driving to school)

Bring the above copies AND the enclosed Student Parking Agreement completed and signed by you and your parent/guardian to:

Ms. Williams in Mr. Kelly's office (North end)

IF YOU DO NOT HAVE A PARKING PERMIT YOU CANNOT PARK ON SCHOOL GROUNDS. In addition, only SENIOR students with a valid SENIOR License, Class D, are eligible to drive to school, NYS Law: DMV Publication C-4.

Student Parking Agreement

In an effort to provide enough parking spaces for all registered vehicles, both your compliance with and your assistance in enforcing the student parking rules are essential. Remember, parking on school property is a privilege, not a right. Noncompliance or abuse of these rules and/or the spirit of these rules can constitute grounds for temporary or permanent removal of this privilege and/or detention or suspension for any of all individuals involved.

1. **Only SENIORS with valid NY State Senior Licenses** are allowed to drive to school or park on school property.
2. Only the student to whom a vehicle is registered is permitted to drive that vehicle.
3. Students will be issued one hanging parking tag. This tag is to be displayed from the rear view mirror at all times while the vehicle is parked on school property. The parking registration number and license plate number must face forward so as to be easily viewed through the front windshield. Repeated offenses will result in temporary or permanent suspension of parking privileges.
4. Unsafe driving as judged by school personnel (including paraprofessionals, teachers, custodians, administrators), to include but not be limited to speeding, passing stopped buses, "peeling out", and driving over grass, will be considered sufficient grounds for temporary or permanent suspension of parking privileges in addition to detention or suspension in extreme cases.
5. Parking or driving on school property during a parking privilege suspension and other demonstrations of irresponsible and/or insubordinate behavior will be considered as actions worthy of more severe penalties, to include extended or permanent parking privilege suspension and/or suspension from school.
6. Students may go to their vehicles at their dismissal time only. **If a student requires an item from his/her vehicle during the school day, the student is to obtain a pass to do so from an administrator and then go directly to and from the vehicle unaccompanied by any other student. They must exit and re-enter through the main entrance.**

I have discussed the rules of the Student Parking Contract with my son/daughter.
